Please give some examples for using cultivated biodiversity. How do you see the importance of peasant, local or traditional varieties for agriculture and vegetable gardening?

At the moment ProSpecieRara and Sativa Rheinau AG bring about 200 different vegetables-varieties to the market under a special label that stands for the protection of biodiversity of cultural plants and domestic animals.

For special landscapes and regions and farmers that produce regional specialities. Traditional varieties could be very interesting. Products with history are very interesting for many clients (Restaurants, regional markets, direct marketing).

Which are the main (legal) obstacles that constrain you? How can you avoid them?

At the moment we face no real legal obstacles. But that could change in the future if Switzerland is adapting EU-law.
